- To develop a continuous improvement system based on medium-term plans, annual action programs, and regular audits, under the guidance of top management.
- To incorporate a full range of green features into the services and products we provide, such as non-use of toxic substances, use of recyclable materials, economical consumption of energy and water during usage, and options for reuse and recycling at the end of their lifecycle.
- To train our executives, fostering continuous ecological awareness and ensuring their optimal performance.
- To continuously monitor the results of the programs we implement and review the application of the environmental conditions we have set.
- To encourage our suppliers and partners to develop new products and services that are less harmful to the environment, revitalizing the market.

We are committed to continuous improvement, pollution prevention, and compliance with applicable legal and other requirements related to the environmental aspects of our hotel unit.

We provide a framework for setting and reviewing environmental objectives and targets.
